FCCJ Annual General Assembly

The thirteenth FCCJ Annual General Assembly was held on Tuesday, 3 April at the Embassy of Finland attended by 35 chamber members and members of its Board of Trustees. Due to the anticipated strong spring storm, there were a large number of late cancellations.

Three new board members were elected, Yasuyuki Oda, Kone Japan, Marko Salonen, Finpro/Finland Trade Center and JP Takala, Nokia Siemens Networks Japan Corp..

After the assembly proceedings, Ambassador Jari Gustafsson hosted a buffet dinner with a lot of active discussions between the members.

FCCJ takes back the Stora Enso Cup!

The 20th Stora Enso Cup, the golf challenge between the Swedish and Finnish Chambers was played on Friday, 20 April at Taiheiyo Club Gotemba West in Shizuoka Prefecture. The event was played in quite nice spring weather, mostly cloudy, a few drops of rain but warm enough for a fine day of golf.

36 players participated in the competition (17 from FCCJ, 19 from SCCJ), including four guests. Notable was that 19 (more than half) of the players were Japanese.


The Finnish Chamber came on now top after the SCCJ had taken the previous Cup. This FCCJ beat the Swedish Chamber by a fairly large margin, 3.8 strokes on average per

player, 80.2 versus 84.0 as average for the best 80% in each team. The FCCJ now has two more wins than the SCCJ, 11 against 9.

The best golfer on the day was, with some margin, Sakari Romu (FCCJ) who was Best Net (71), Best Gross (79) and also took one near pin prize.

Foreign Chambers Business Confidence Survey

The 21st edition of the Foreign Chambers Business confidence Survey has just been completed and we give you a "sneak peak" into the preliminary results.

This survey shows, as could be seen already in the Fall 2011 survey, that the problems and uncertainties caused by the 3.11 disaster are now to a large extent behind and now 3.11. is more seen as an opportunity than a threat. All indexes, from views on the Japanese economy to the performance of the companies, as well as their forecasts for the future, rose about 15-25% from the Fall 2011 survey. Only the profitability forecast for the next 6 months was same as in the previous survey, but still showed a healthy index of +0.68 on the scale from -2 (strong decline) to +2 (strong improvement).

The Japanese economy for the next 6 months is expected to grow further - the index (on a scale from +2 to -2) was now +0.47 (compared to +0.31 in fall 2011), and looking 12 months ahead, the companies see an even stronger turn for the better and the index was now +0.67, an improvement from the +0.55 in the previous survey.



The strategies of the foreign-affiliated companies in Japan continue to be rather bullish. 73% (68% in the fall 2011 survey) are looking for further growth. 4% are planning to downsize, but only 1% (four companies out of the surveyed 325) are considering withdrawing from Japan.

The thirteenth Annual General Assembly handled matters according to our Articles of Association. The reports from 2011 and activity plans and budget for 2012 were approved. The membership fees remain unchanged; 150,000 yen for corporate members, 75,000 yen for associate corporate and 20,000 yen for individual members.

Four board members (Masaoki Fujita, Coil Center Fujita Co., Ltd., Sakari Romu, Finnair, Veli Solehmainen, Vaisala K.K. and Hiroaki Sugawara, Finn Corporation) whose term ended where re-elected for another two years. Yasuyuki Oda, Kone Japan, Marko Salonen, Finpro/Finland Trade Center and JP Takala, Nokia Siemens Networks Japan Corp. were elected new board member.

Board of Trustees member Taiji Watanabe who was up for re-election was elected for another 5 year term. Yasuyki Amakusa of Marubeni Corporation replaces Yukichi Nakamura who has moved to Indonesia.

Auditors in 2012 are Katsuro Ohata, Wartsila Japan and Kauko Laitinen, The Finnish Institute in Japan
